3. NOC invites electronic bids from the eligible bidders for the procurement of Contract stated above under **International Competitive Bidding Procedures.**

4. To participate in this bidding, the bidders must have been currently operational in the manufacturing industry / fabrication of Aircraft Fuel Bowser for at least 5 consecutive years and Over the past five (5) years as of the date of bid opening must have completed at least five (5) successful contracts of supply and delivery of aircraft refuellers of 12 KL capacity or more.

7. Pre-bid meeting shall be held at office stated in the Bidding Document.

8. Interested Bidders shall submit the electronic Bids through www.bolpatra.gov.np/egp to Nepal Oil Corporation Limited on or before **12.00 hrs on 22nd March 2019**

9. Bids shall be opened in the presence of Bidders' representatives who choose to attend on **14.00 hrs of 22nd March 2019** at the office stated in the Bidding Document. Bids must be valid for a period of **120 days** counting from the day of bid opening and must be accompanied by bid security, amounting to **NRs 3.6 million or USD 32,800.00** issued directly by a reputable bank and counter guaranteed by an "A" Class local bank accredited by Nepal Rastra Bank which shall be **valid for minimum 30 days beyond the bid validity period.**

10. In the comparison of Bids, Domestic Preference Scheme will be applied in accordance with the provisions stipulated in the **Bidding Documents.**

11. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognised with effect from the original bid submission deadline.
