- The Government of Nepal [GoN] has allocated funds and received a grant from Government of India (GOI) towards the cost of Post-Earthquake Reconstruction School Project and intends to apply part of the funds to cover eligible payments under the Contract for Construction of School buildings, Toilet and Water Supply facilities including furniture and site development works in 4 (Four) schools in Kathmandu district and 2 (Two) schools in Kavre district (GOI/CLPIU(E)/2076/077-6 schools) and Construction of Central Library Building at Kirtipur,Kathmandu district (GOI/CLPIU(E)/2076/077-TUCL).Bidding is open to all eligible bidder from Nepal and India.
- Central Level Project Implementation Unit (Education) invites electronic bids from eligible bidders for the construction of RCC framed buildings complex as mentioned below under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.
